Subject: Broad Support in Key States for Voting Rights Proposals Considered by Congress

Date: August 16, 2021

Seven new Public Policy Polling surveys conducted among voters in Alaska, Arizona, Maine, Montana, Nevada, Pennsylvania, and West Virginia find strong support for proposals being considered by Congress that would ensure access to voting and protection of voting rights in the United States.

The following is a summary of the findings.

- Voters in each state believe Congress should take action to protect the freedom to vote and that Congress has a responsibility to act if states are making it more difficult to vote and/or if states are discriminating against voters of color.
- Voters in each state strongly support key provisions of the For the People Act and the John Lewis Voting Rights Advancement Act.
- Voters in each state are less likely to support a candidate who has made voting more difficult.
- Voters in each state oppose allowing a filibuster to get in the way of voting rights legislation, and voters in each state believe that Democrats should pass voting rights legislation even if no Republicans support it.

CONGRESSIONAL RESPONSIBILITIES

Congress' Responsibility to Ensure That All Eligible Voters Can Cast Ballot without Burden

Voters overwhelmingly agree that Congress has a responsibility to ensure that eligible voters are able to cast their ballots without burdens. Arizona voters, for instance, support this by a 76-21% margin and West Virginia voters support this by a 63-23% margin.

Congress' Responsibility to Take Action if States Discriminate Against Voters Based on Race

Voters agree that Congress has a responsibility to take action if states discriminate against voters based on race. Arizona voters, for instance, support this by a 77-20% margin and West Virginia voters support this by a 73-23% margin.

Congress' Responsibility to Take Action if States Make Voting More Difficult

Voters across all seven states are in strong agreement that Congress has a responsibility to take action if states make voting more difficult for their citizens. Arizona voters, for instance, support this by a 69-29% margin and West Virginia voters support this by a 59-35% margin.

Congress' Responsibility to Protect Election Workers and Voters

An overwhelming majority across all of the states surveyed think Congress has a responsibility to protect election workers and voters from intimidation, harassment, and threats. Arizona voters, for instance, support this by a 78-20% margin and West Virginia voters support this by an 80-18% margin.

CONGRESSIONAL PROPOSALS

Preventing States from Removing Voters from Voter Rolls without Consent

A majority across all seven states surveyed support a proposal to prevent states from removing voters from voter rolls without their consent. Arizona voters, for instance, support this by a 54-32% margin and West Virginia voters support this by a 51-34% margin.

Reducing Long Lines and Wait Times at Polling Places

Voters show overwhelming support for reducing long lines and wait times at polling places. Arizona voters, for instance, support this by a 74-15% margin and West Virginia voters support this by a 61-27% margin.

Preventing Polling Place Closures in Rural and Urban Communities

Voters across all seven states show strong support for preventing the closure of polling places in rural and urban communities, a provision in the For the People Act. Arizona voters, for instance, support this by a 73-18% margin and West Virginia voters support this by a 68-23% margin.

Giving All Eligible Voters Option to Vote by Mail

A majority of voters across six of the seven states support giving all eligible voters the option to vote by mail without needing to provide an excuse, ranging from 63% in Arizona (with a majority—54%—in strong support) to 52% (in Pennsylvania). The only state





which doesn't see a majority in support for this proposal is West Virginia, where 40% are in support, with 59% opposed.

Automatic Registration When Applying for a Driver's License

A majority of voters support automatically registering eligible citizens to vote when they apply for a driver's license, unless they are opted out. Arizona voters, for instance, support this by a 63-34% margin and West Virginia voters support this by a 60-34% margin.

Ensuring Fair Districts and Stopping Partisan Gerrymandering

The proposal to ensure fair districts and stop partisan gerrymandering is another proposal that garners strong support, and is one of the most popular proposals across the seven states surveyed. Arizona voters, for instance, support this by a 76-9% margin and West Virginia voters support this by a 68-14% margin.

Preventing States from Taking Authority from Local Elections Officials

Strong majorities of voters show support for a proposal that would prevent states from taking authority from local elections officials. Arizona voters, for instance, support this by a 66-19% margin and West Virginia voters support this by a 60-21% margin.

Preclearance: Department of Justice Review of State Voting Laws to Prevent Racial Discrimination

Voters show strong support for allowing the Department of Justice to review state laws before they go into effect in order to make sure they do not discriminate against voters based on race. Arizona voters, for instance, support this by a 65-30% margin and West Virginia voters support this by a 64-31% margin.

CANDIDATE SUPPORT

Likelihood to Vote for Candidate Supporting Legislation Making it Harder for Eligible Voters to Cast Ballots

Voters care about voting rights, and a majority across all seven states polled say they are less likely to vote for candidates who support legislation erecting unnecessary barriers to voting.

LEGISLATIVE PROCESS

Passing Voting Rights Legislation without 60 Votes

Voters in each state also think the Senate should be able to pass voting rights legislation with a majority of Senators, rather than needing votes from 60 Senators.

Public Policy Polling surveyed 635 Alaska voters from August 3-4, 2021. The margin of error is +/- 3.9%. 53% of interviews for the survey were conducted by telephone and 47% by text message.





Public Policy Polling surveyed 519 Arizona voters from August 3-4, 2021. The margin of error is +/- 4.3%. 40% of interviews for the survey were conducted by telephone and 60% by text message.

Public Policy Polling surveyed 523 Maine voters from August 3-4, 2021. The margin of error is +/- 4.3%. 50% of interviews for the survey were conducted by telephone and 50% by text message.

Public Policy Polling surveyed 554 Montana voters from August 3-4, 2021. The margin of error is +/- 4.2%. 50% of interviews for the survey were conducted by telephone and 50% by text message.

Public Policy Polling surveyed 587 Nevada voters from August 3-4, 2021. The margin of error is +/-4.0%. 50% of interviews for the survey were conducted by telephone and 50% by text message.

Public Policy Polling surveyed 648 Pennsylvania voters from August 3-4, 2021. The margin of error is +/- 3.9%. 50% of interviews for the survey were conducted by telephone and 50% by text message.

Public Policy Polling surveyed 702 West Virginia voters from August 3-4, 2021. The margin of error is +/- 3.7%. 50% of interviews for the survey were conducted by telephone and 50% by text message.
